During 2018, the Company declared common stock dividends totaling \$1.680000 per share which consisted of \$1.378178 in ordinary dividends. In accordance with the Internal Revenue Code ("the Code"), \$0.301822 per share of the dividend declared on December 14, 2018 and paid on January 28, 2019 will be treated as a 2019 distribution.

In 2018, the Company also paid series A preferred stock dividends totaling \$1.937600 per share which consisted of \$1.937600 in ordinary dividends, series B preferred stock dividends totaling \$1.937600 per share which consisted of \$1.937600 in ordinary dividends, and series C preferred stock dividends totaling \$1.875000 per share which consisted of \$1.875000 in ordinary dividends.

No portion of the Company's 2018 distributions consisted of excess inclusion income under the Code.
