In 2017, the Company also paid series A preferred stock dividends totaling \$1.937600 per share which consisted of \$1.937600 in ordinary dividends, series B preferred stock dividends totaling \$1.937600 per share which consisted of \$1.937600 in ordinary dividends, and series C preferred stock dividends totaling \$0.682290 per share which consisted of \$0.682290 in ordinary dividends.

No portion of the Company's 2017 distributions consisted of excess inclusion income under the Code.
